Accounts 2021 – Context and Forecast

2016-2018 – Developing the Plan

- Average Annual Spend £3,757 (of which Consultancy £3,375)
- Supported by grants from Locality and PWRA
- Funds held on the Forum's behalf by Camden

2019 – A Transitional Year

- No income or expenditure (website services pre-purchased)

2020-2024 – Supporting the Mission Statement

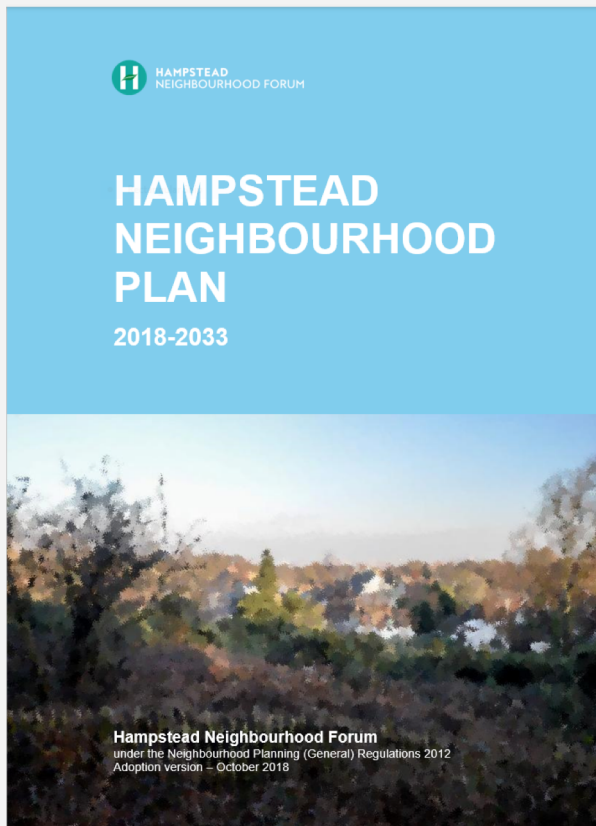

150 proposals reviewed

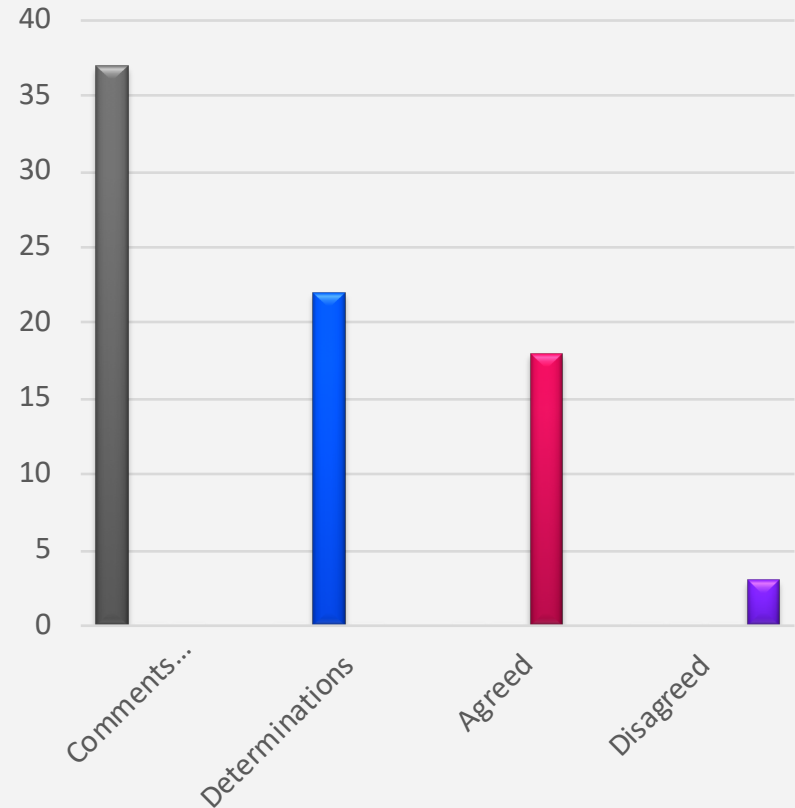
Camden made 22 determinations on comments we submitted

Agreed with us on 18; disagreed on 4

6 applications withdrawn, presumably refused

Commented on numerous tree applications; Camden disagreed on 1

Hampstead Community Air Quality Project

- Started in September 2021
- 10 locations measured for 1 year
- NO2 Levels measured through diffusion tubes
- About 20 volunteers involved
- 3 schools participating: UCS Junior, Devonshire House School, Maria Montessori School

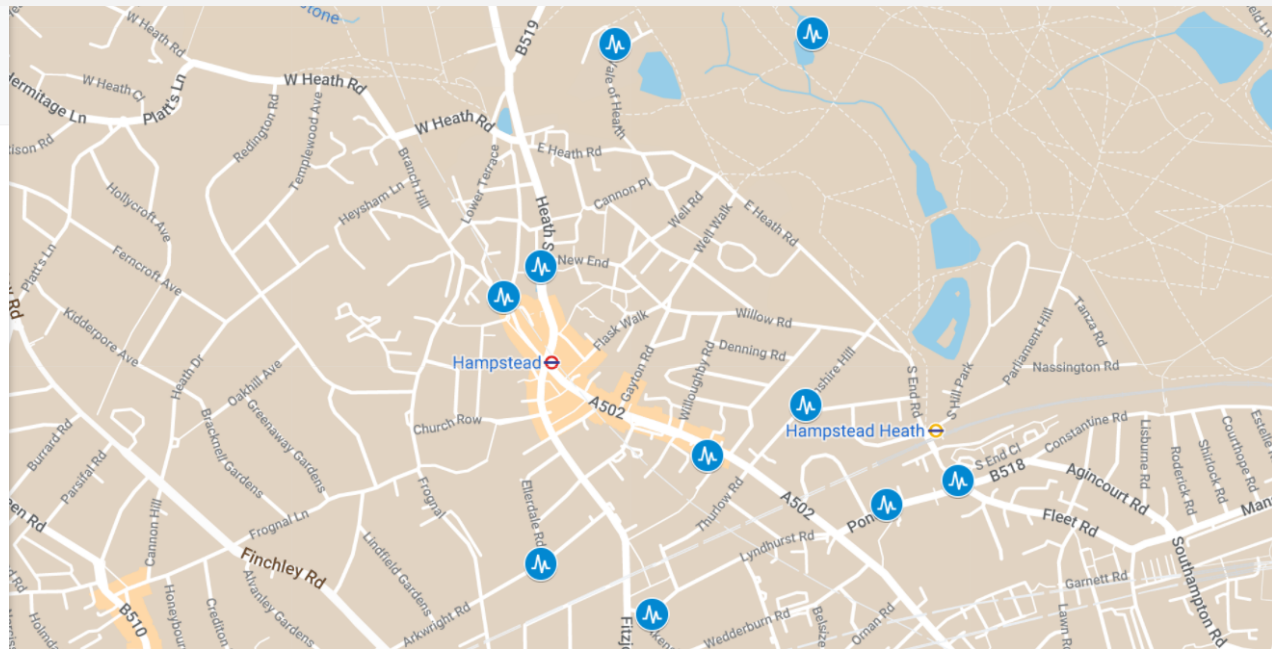
Map of Locations

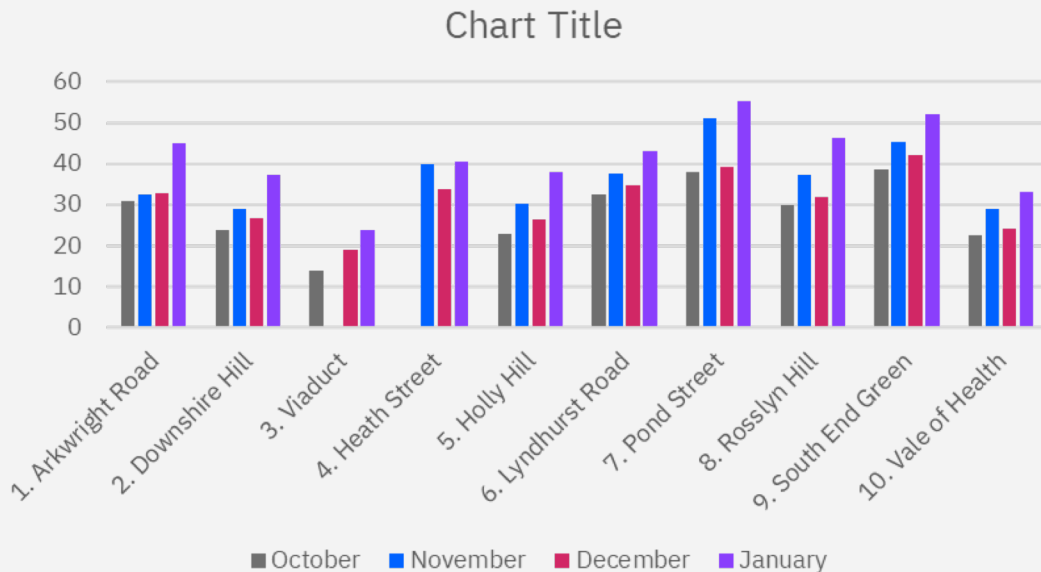
- 1 - Arkwright Road - Devonshire House School

- Based on the 2015 study
- Three of the locations are more relevant for schools and school run
- One location in the middle of Hampstead Heath

Results

- Preliminary Results (only 4 months)
- We have collected good quality data – confidence in what it tells us
- It is early to compare data with 2015 – there is an improvement –analysis ongoing
- Still work to do to meet Camden objectives
- Attention needed in the areas close to schools



Camden is working towards the updated **WHO 2021** air quality guidelines ($25 \mu\text{g}/\text{m}^3$ 24-hour mean) and will continue to advocate for stricter legal limits for NO_2 and particulates in the UK.
